# INSTRUCTIONS

1. A \$5.00 non-refundable fee is required for each request. If the Bureau has no record for the information requested or the data supplied is insufficient, the fee will be applied to the cost of the search.
2. **PRINT OR TYPE** all requested information on front of form. Submitting **ONLY** a name or name and address does not provide enough information for a proper search of the vehicle files.
3. If **requesting your own record**, complete Sections A, B and C only. Notarization is NOT required.
4. If requesting someone else's record, complete Sections A, B, C and either D or E.
5. A separate form is required for each record requested. Only one form is required when requesting a title/odometer history. When requesting a title or odometer history, more than one transaction may be available on that particular vehicle. To determine the correct fee, you can call the Customer Call Center at:

- **Title History** ..... A copy of the title transaction documents will be provided. **NOTE:** Sales tax and purchase price are considered confidential and will not be provided.
- **Odometer** ..... A copy of the title/renewal transaction will be provided. **NOTE:** Sales tax and purchase price are considered confidential and will not be provided.
- **Encumbrance** ..... Includes basic information listed above in addition to lienholder's name and address and expiration date.
- **Insurance** ..... A copy of the title/renewal transaction will be provided. **NOTE:** Sales tax and purchase price are considered confidential and will not be provided.
- **Basic** ..... Includes name, address, title number, tag, vehicle identification number (VIN), make and expiration date of tag.
