Upper Dublin Township Peddling & Soliciting Permit Application Instructions

Under Chapter §171 of the Upper Dublin Township Code, ALL persons desiring to engage in PEDDLING and/or SOLICITING in Upper Dublin Township shall submit a written application to the Police Department on a form furnished by the Police Department. ALL applicants shall provide the application fee of \$100, along with two (2) passport-size (2 1/2" x 3") color photographs of him/herself, taken NOT MORE than six (6) months prior to the date the application is being made.

NO soliciting/peddling shall be allowed by the applicant before the permit is approved and the Identification Card is issued to the applicant.

PRIOR TO MAKING APPLICATION TO THIS POLICE DEPARTMENT, ALL "HOME IMPROVEMENT CONTRACTOR" APPLICANTS SHALL HAVE MADE & RECEIVED FROM THE STATE OF PENNSYLVANIA, A VALID & CURRENT "HOME IMPROVEMENT" REGISTRATION.

The applicant shall state name, age, sex, home address and phone number, driver's license number (or ID card) & state, name, address, phone number and contact name for his employer (if any), as well as make, model, license plate number and state of any vehicle he may be using. The applicant will check off the box indicating whether he or she was ever convicted of a felony, misdemeanor or any crime involving moral turpitude; an answer "YES" to this question will be grounds to deny the applicant permission to engage in canvassing, peddling and/or soliciting in Upper Dublin Township.

The Police Department-issued identification card will be valid for a period of three months. Such ID card must be carried and prominently displayed while the person is engaging in activity covered by this permit, and must be presented upon request of Police. Failure to carry and display the ID card will render the person liable for citation and immediate cancellation of his or her solicitation permission. Such card will not be transferred or loaned from the person whose photograph and identity appears on the card, to any other person. This will render the permission invalid and may not be renewed.

In all instances, NO SOLICITING, CANVASSING, OR PEDDLING SHALL TAKE PLACE BETWEEN THE HOURS OF 9p-9a, NOR AFTER DARK.

Failure by the applicant to truthfully and completely fill out the application will result in the application for a permit being denied.
